

ABI MONTHLY REPORT¹ – July 2022

(Main evidence)

BANK LENDING PERFORMANCE

1. In June 2022, **loans to households and non-financial corporations were up yoy by +3.3%**. This result is derived from estimates based on data published by the Bank of Italy relating to loans to households and non-financial corporations (calculated including loans that have been securitised and net of variations unrelated to transactions, e.g. changes due to fluctuations in exchange rates, value adjustments or reclassification) (*cf. Table 2*).
2. In May 2022, **loans to non-financial corporations posted a +2.3% yoy increase. Loans to households were up yoy by 4.0%**.

LENDING INTEREST RATES

3. In June 2022, **interest rates on new loans** remain at low levels and showed the following trends (*cf. Table 3*):
 - the **average rate on total loans** is **2.18%** (2.16% in the previous month and 6.18% prior to the onset of the crisis, at the end of 2007);
 - **the average rate on new business loans** is **1.49%** (1.20% in the previous month; 5.48% at the end of 2007);
 - **the average rate on new loans for house purchasing** is **2.05%** (1.92% in the previous month; 5.72% at the end of 2007).

CREDIT QUALITY

4. **Net bad loans** (i.e. net of the write-downs and provisions already made by the banks with own resources) in May 2022 amounted at **16.3 billion euros** down by about 0.4 billion euros compared to the previous month and about 1.7 billion euros lower than in May 2021 (*cf. Table 1*). Compared to the highest level of net bad loans reached in November 2015 (88.8 billion), the decline is 72.5 billion euros.
5. **The ratio of net bad loans to total loans** is equal to **0.93%** in May 2022, (it was 1.04% in May 2021, 1.50% in May 2020 and 4.89% in November 2015).

¹ The ABI monthly report makes available a series of quantitative information before any other survey regarding the same data. This is possible because the banks themselves have produced this information.

CUSTOMER FUNDING TREND

6. In Italy, in June 2022, **total funding** (deposits from resident customers and bonds) grew by **+2.4%** yoy. **Deposits** (current accounts, certificates of deposit, repurchase agreements) **increased**, in the same month, by almost **59 billion euros compared to the previous year** (an increase of **+3.3%** yoy), while **medium- and long-term funding**, i.e. through bonds, **decreased by 11 billion euros** in absolute terms, over the last 12 months (equal to **-5.2%**) (cf. Table 4).

INTEREST RATES ON DEPOSITS

7. In June 2022, the **average interest rate on total bank funding** from customers (the sum of deposits, bonds and repurchase agreements in euro from households and non-financial corporations) **in Italy is 0.44%** (same value as the previous month) as a result of:
- the **rate charged on deposits** (current accounts, savings deposits and certificates of deposit), equal to **0.31%** (same value as the previous month);
 - the **rate on repurchase agreements**, which stands at **1.02%** (0.94% in the previous month);
 - the **outstanding bond yield, equal to 1.74%** (1.72% in the previous month; cf. Table 5).

SPREAD BETWEEN THE LENDING RATE AND DEPOSIT RATE

8. The **spread** between the average lending rate and the average rate on household and non-financial corporations funding **in Italy** remains at particularly low levels, in June 2022 is **174 basis points**, (172 in the previous month) showing a sharp decrease over the more than 300 basis points prior to the onset of the crisis (335 basis points at the end of 2007).
