

ABI MONTHLY REPORT¹ – September 2022

(Main evidence)

BANK LENDING PERFORMANCE

1. In August 2022, **loans to households and non-financial corporations were up yoy by +4.1%**. This result is derived from estimates based on data published by the Bank of Italy relating to loans to households and non-financial corporations (calculated including loans that have been securitised and net of variations unrelated to transactions, e.g. changes due to fluctuations in exchange rates, value adjustments or reclassification) (*cf. Table 1*).
2. In July 2022, **loans to non-financial corporations posted a +3.7% yoy increase. Loans to households were up yoy by 4.0%**.

LENDING INTEREST RATES

3. In August 2022, **interest rates on new loans** remain at low levels and showed the following trends (*cf. Table 2*):
 - the **average rate on total loans, after the increase of ECB interest rates by 50 basis points**, is **2.32%** (2.25% in the previous month and 6.18% prior to the onset of the crisis, at the end of 2007);
 - the **average rate on new business loans** is **1.26%** (1.31% in the previous month; 5.48% at the end of 2007);
 - the **average rate on new loans for house purchasing** is **2.13%** (2.15% in the previous month; 5.72% at the end of 2007).

CREDIT QUALITY

4. **Net bad loans** (i.e. net of the write-downs and provisions already made by the banks with own resources) in July 2022 amounted at **16.8 billion euros** up by about 0.8 billion euros compared to the previous month but about 1.0 billion euros lower than in July 2021 (*cf. Table 3*). Compared to the highest level of net bad loans reached in November 2015 (88.8 billion), the decline is 72.1 billion euros.
5. **The ratio of net bad loans to total loans** is equal to **0.95%** in July 2022, (it was 1.03% in July 2021, 1.41% in July 2020 and 4.89% in November 2015).

CUSTOMER FUNDING TREND

6. In Italy, in August 2022, **total funding** (deposits from resident customers and bonds) grew by **+2.4%** yoy. **Deposits** (current accounts, certificates of deposit, repurchase agreements) **increased**, in the same month, by **61 billion euros compared to the previous year** (an increase of **+3.4%** yoy), while **medium- and long-term funding**, i.e. through bonds, **decreased by 12 billion euros** in absolute terms, over the last 12 months (equal to **-5.7%**) (*cf. Table 4*).

INTEREST RATES ON DEPOSITS

7. In August 2022, the **average interest rate on total bank funding** from customers (the sum of deposits, bonds and repurchase agreements in euro from households and non-financial corporations) **in Italy is 0.46%** (0.45% in the previous month) as a result of:

- the **rate charged on deposits** (current accounts, savings deposits and certificates of deposit), equal to **0.32%** (same value as the previous month);
- the **rate on repurchase agreements**, which stands at **0.84%** (0.88% in the previous month);
- the **outstanding bond yield, equal to 1.81%** (1.78% in the previous month; *cf. Table 5*).

SPREAD BETWEEN THE LENDING RATE AND DEPOSIT RATE

8. The **spread** between the average lending rate and the average rate on household and non-financial corporations funding **in Italy** remains at particularly low levels, in August 2022 is **186 basis points**, (180 in the previous month) showing a sharp decrease over the more than 300 basis points prior to the onset of the crisis (335 basis points at the end of 2007).
