

ABI MONTHLY REPORT¹ – January 2025 (Main evidence)

Compared to October 2023, market rates have further decreased following the ECB rate cuts. In recent months, this trend has continued for short-term rates, while for long-term rates, an inversion occurred in early January, with a rebound being observed.

MARKET RATES

In the first 16 days of January 2025:

1. **The 3-month Euribor rate** averaged **2.76%** decreasing by 8 basis points compared to December 2024 (**2.84%**) and down by **124 basis points** compared to the peak value recorded in October 2023.
2. **The gross six-month BOT rate** was on average **2.56%** decreasing by 6 basis points compared to December 2024 (**2.62%**) and **149 basis points** lower compared to the peak value recorded in October 2023.
3. **The 10-year IRS rate** (widely used in mortgages) averaged **2.50%** increasing by 27 basis point compared to December (**2.23%**) and down by **103 basis points** compared to the peak recorded in October 2023.
4. **The gross BTP rate** was on average **3.68%** increasing by 34 basis points compared to December (**3.34%**) and **131 basis points** lower compared to the peak recorded in October 2023.

LENDING INTEREST RATES

5. In December 2024:

- **the average rate on new loans for house purchasing decreased to 3.10%**, compared to 3.23% in November and lower compared to 4.42% in December 2023;
- **the average rate on new business loans is 4.53%** (4.53% in November 2024 and 5.45% in December 2023);
- **the average rate on total loans** (therefore agreed upon over the years) **decreased to 4.45%** from 4.55% in the previous month (cf. Table 1).

INTEREST RATES ON BANKING FUNDING

6. The **interest rate on new deposits with agreed maturity** (i.e. certificates of deposit and time deposits) in December 2024 **was 3.04%**. In November 2024 this interest rate was higher than the euro area average (3.14% in Italy; 2.79% in euro area). **Compared to June 2022**, when the interest rate was 0.29% (the last month before the start of the official interest rate hikes) **the increase is equal to 275 basis points**.
7. **The yield on new fixed-rate bond issues in December 2024 is 2.41%** with an increase of 110 basis points compared to 1.31% in June 2022.
8. In December 2024, **the interest rate on total amounts of deposits** (current accounts, savings deposits and certificates of deposit), **is 0.91%** (0.93% in the previous month; 0.32% in June 2022).
9. **The interest rate on current account deposits is 0.47%** (0.48% in the previous month; 0.02% in June 2022), taking into account that the current account allows the use of a multitude of services and does not have the function of investment (cf. Table 2).

SPREAD BETWEEN THE LENDING RATE

10. The **spread on new business** (calculated as the difference between the rates on new loans and new funding) with household and non-financial corporations **in Italy**, in December 2024, is **217 basis points**.

STOCK OF CUSTOMER FUNDING

11. **Indirect funding**, i.e. investments in securities held by banks (both under management and held directly by customers) shows an **increase of about 164 billion between November 2023 and November 2024** (56.8

billion attributable to households, 16.2 to non-financial corporations and the remaining to other sectors, financial companies, insurance companies, public administration).

12. In December 2024 **medium- and long-term funding**, i.e. through bonds, increased over the last 12 months by **6.8%** (+7.2% in the previous month).

13. **Deposits**, in their various forms, in December 2024 **increased by 1.7% yoy** (+4.5% in the previous month).

14. In December 2024, **total funding** (deposits from resident customers and bonds) **increased by 2.4% yoy** continuing the positive trend observed since the beginning of 2024 (+4.8% in November 2024; cf. *Table 3*).

BANK LENDING

15. The decline in credit volumes is consistent with the slowdown in economic growth which contributes to depressing the demand for loans: in December 2024, compared to a year earlier, **loans to households and non-financial corporations were down by 1.0%**, easing from the previous month's 1.8% decline; **in November 2024 loans to non-financial corporations were down yoy by 3.6% while those to households remained unchanged** (cf. *Table 4*).

CREDIT QUALITY

16. **In November 2024, net non-performing loans** (i.e., the total of bad loans, unlikely-to-pay exposures, and past due and/or overdrawn exposures, calculated net of write-downs and provisions already made by the banks) decreased to **31.1 billion euros** from 31.6 billion in September 2024 (30.5 billion in December 2023). Compared to their peak level of 196.3 billion reached in 2015, they have decreased by over 165 billion.

17. **In November 2024, net non-performing loans represented 1.51% of total loans.** In September 2024, this ratio was 1.52% (1.41% in December 2023; 9.8% in 2015; cf. *Table 5*).
